c.) IN LIEU PAYMENT - \$10361.00						
In addition to other compensation, each certificated, full time employee, who is enrolled in the Dist./Assoc. medical, dental and vision insurance plans, shall have their annual compensation increased by the amount of this payment. The payment shall be made in equal installments over the normal monthly payroll. Eligible part-time employees shall receive a proportional share of the "in lieu payment" subject to enrollment in the insurance plans. \$4274.00 per year for family coverage as a district contribution.
