School Description

Forest Grove Elementary School is located in the community of Pacific Grove on the Monterey Peninsula. The school population is 405 students consisting of 78% Caucasian, 1% Black, 6% Asian, 14% Hispanic and 1% other. It is one of two elementary schools in a district of 2000 students with one middle school and one high school.

Mission Statement

Forest Grove School seeks to provide a quality educational program for each of its students. We recognize that the school serves students of different backgrounds, abilities and interests. Community Involvement

Forest Grove School has a large number of parent and community volunteers who work diligently at the school for the good of our students and staff. Parents improve the school grounds bv sponsoring improvement days. Social activities include community fundraising events for programs district wide. 1. Student Achievement

In the spring of 2002, Forest Grove students participated in statewide testing. The Standardized Testing and Reporting System (STAR) compares how well California children perform in relation to other children throughout the state and nation. The test results in reading, math, language, and spelling are as follows.

The 2001-02 API score was 836, an increase of 18 for the 2000-01 API score. All groups and subgroups exceed their targets making Forest Grove eligible for the Governor's Performance Award

Forest Grove School met the Assessment and school wide growth/subgroup growth goals set by the state of California. Forest Grove's school wide API scores was 828 qualifying it for the Governor's Performance Award Program. Similar schools and statewide API ranking were not available at the time of publishing this document.

2. Student Attendance

In the 2001-02 school year, Forest Grove student attendance was in excess of the 96.75% level. The percentage of students who attended less than a minimum day for unexcused reasons was 4.46%.

Families are encouraged to support the school's attendance policy by calling to notify the school of illness, arranging for independent study when a trip or emergency takes the child away from the school, and by having the child complete missed work.

Forest Grove School makes an effort to promote attendance and prevent future dropouts by incentive programs for attendance and punctuality, studentteacher conferences. parent-teacher-principal conferences, counseling referrals and parenting classes.

3. Expenditures and Services

Total General Fund operating cost for the Pacific Grove Unified School District for the 2001-02 school vear was approximately \$15,162,839 or about \$6,824 per student.

Instructional program expenditures included teachers, aides, textbooks and other instructional material. School support services are made up of administration, counseling and library services, as well as custodial, maintenance, and transportation support.

As an individual school site, Forest Grove Elementary School received special categorical funds in the amount of \$355,214. This revenue represents income from several different special state or federal projects such as School Improvement and ESL.

4. Class Size

The district is making an ongoing effort to evaluate class sizes at all levels for possible reduction. As of June 2000, our classes averaged:

Forest Grove School has 100% of its K-3rd grades participating in class size reduction. Class sizes and teaching loads are distributed evenly across the grades.

5. Teacher Assignments

At Forest Grove School, the 17 classroom teachers, one special education teacher, and the school principal, all have appropriate credentials and qualifications. Additional certificated staff include an instrumental and vocal music teachers three days a week, a speech pathologist four mornings a week, a psychologist two days a week, and a credentialed P.E. teacher daily.

6. Textbooks and Materials

District Curriculum Committees, with input from teachers, select instructional materials from a stateapproved list and make recommendations to our Board of Education. In response to the new State standards, we have selected standards based instructional materials in all core curriculum areas.

Instructional materials in all areas are reviewed regularly. The library and computer center provide extensive additional instructional material support.

7. Counseling and Student Support Services

The school provides students with services that support classroom instruction. The school receives the services of:

8. Substitute Teachers

The district and school maintain lists of credentialed teachers and the areas in which they are qualified to teach.

The district makes an effort to attract qualified substitute teachers by increasing substitute salaries to compete with those in neighboring district.

9. School Facilities and Safety

Forest Grove School provides a safe, clean environment for learning. Our custodial staff of three performs basic cleaning operations in every classroom every day.

The Forest Grove School PTA initiated an upgrading of all playgrounds through additional equipment and refurbishing of play areas. Forest Grove has undergone construction to rebuild all of its infrastructures and was completed in February of 2002.

The safety of students is addressed through participation in such programs as Safe Phone, McGruff, Fire Prevention, DARE, Anti Bullying counseling program, and Personal Safety. Emergency preparedness includes monthly fire and earthquake drills. A parent and teacher telephone tree has been implemented at Forest Grove School, playground supervision has been increased and school rules remain strictly enforced.

The Forest Grove Safety Plan is reviewed and updated by staff and administration each year. Key areas are reviewed including primary and secondary evacuation sites, communication, and evacuation procedures.

10. Teacher Evaluation

The Pacific Grove Unified School District maintains a system of evaluation of certificated employees with the intent to continually improve instruction for its pupils. An additional purpose of evaluation is to identify and reinforce the outstanding professional competency of certificated employees.

This system includes yearly performance objectives, based on State mandated criteria, formal and informal performance observations with follow-up conferences, and a written evaluation report at least once every two years for tenured teachers and every year for probationary and temporary teachers.

In support of the District's evaluation process, our teachers have numerous opportunities for input and professional improvement. In addition to site level sessions, the district provides ongoing training in areas of interest and need.

11. Discipline and Climate for Learning

A comprehensive school wide management plan was developed to address behavioral expectations on the playground, in the cafeteria, and any other common areas. It is revised annually. A basic set of school rules and consequences was developed. Each teacher devises and posts classroom rules appropriate to individual grade level and teaching style. Programs currently in place to enhance the learning environment include:

* Here's Looking At You 2000 (to promote responsibility, self-esteem, and decision making)

- * Drug Abuse Resistance Education (DARE)
- Falcon Club (to promote good citizenship, punctuality and responsibility)
 * Boar Councilors
 - Peer Counselors Art Docents Community of Caring Character building program Numerous after school and lunch time activities expand and enrich the school day including chorus, chess club, computer classes, drama workshops, recreational football, soccer, basketball, baseball, dance and twirl club, Boy and Girl Scouts, dancing, and Gifted and Talented Education (GATE).

12. Training and Curriculum Improvement

Formal staff development training occurs every Thursday for elementary and middle school staff. PGUSD offers extensive options of courses for teachers to select from. All staff development occurs after school or on Saturdays. Teachers are also encouraged to attend conferences.

Staff development activities, essential for maintaining and improving equality education, emphasize the following areas:

- * Differentiated instruction
- * An integrated, literature-based language arts program, which includes reading, writing, listening and speaking
- * A problem solving, manipulative-based mathematics and science program
- * Integration of all subject areas
- * Higher-level thinking skills
- * Cooperative learning and peer coaching
- * Addressing the needs of students with special needs
- * Technology courses

District Curriculum Committees determine standards for each subject area and grade level. Curriculum assessments have been designed to evaluate the achievement of these standards. Curriculum committees meet to revise standards and assess student progress toward standards.

13. Quality of Instruction and Leadership

The quality of leadership and the instructional programs at Forest Grove School are excellent. Curriculum is appropriately aligned with state frameworks and model curriculum guidelines for all subject areas.

Parents support the program through classroom volunteer efforts and attendance at parent conferences. Our student population is 405, and we have over 97% attendance at parent conferences. More than 200 parents volunteer time and expertise in the classroom. Instructional Aides work with students in small group and individualized instruction. Funding for this program is provided by the School Improvement Plan. Parents express high satisfaction with the educational program their children receive.

School curriculum exhibits rigorous academic content consistent with professional and community standards. Grade-level standards and expectations exist for homework and for each curricular area within the school.

Formalized testing is used to identify students in significant sub groups and to create individual education programs for students with special needs.

High expectations are held for student learning and student achievement is maintained at a high level. There is a maximum use of instructional time. Students understand the expectations for their assignments, and direct instruction is evident in all classrooms.

The expectations held by staff members encourage all special needs students to achieve to their highest levels of ability at Forest Grove School. The staff employs instructional methods that enhance the learning of all students while providing a positive atmosphere that encourages success and enhances self-esteem.

Regular formal and informal communication achieves excellent articulation among the regular and support staff. School leaders are knowledgeable about curriculum and instructional practices. Leadership and responsibility are shared among staff members.

Program Strength Recognition

In the past, Forest Grove School has received recognition for program strength in leadership.
