April 30,2019	Parent at the Lighthouse Ave raised concerns regarding loose paint on the Annex building adjacent to the Lighthouse/Dual Language Preschool.
May 02,2019	M3 tests paint chips from Pine Ave and Lighthouse Locations. Results Positive
May 20,2019	District/Site Administration Close both sites and re- locate summer school to RHD site
May 23, 2019	M3 tests soil at PGAE Library, Lighthouse/Dual Language site and Pine. Ave. Samples came back well below the acceptable levels for lead concentration on a playgraound.
May 30, 2019	Lighthouse/Dual Language Classrooms released by the district and Summer Camp resumes June 10-July 5th.
June 06,2019	Mitigation Update from Director of Facilities, Matt Kelly.
